During the month of Dec., 2014 the Corporation sanctioned Rs.631.04 lakh for the training of 5827 Persons with Disabilities under its scheme of Financial Assistance for Skill & Entrepreneurial Development. The particulars of these trainings are enclosed at **Appendix-I.**

5. SCHOLARSHIPS TO STUDENTS WITH DISABILITIES

Under National Scholarship (Trust Fund) Scheme fresh scholarships were released to 501 students with disabilities for the total amount of Rs. 2,79,65,591/- (Rs. Two Crore Seventy Nine Lakh Sixty Five Thousand Five Hundred Ninety One only) during the month of Dec., 2014 for first Quarter of Academic Year 2014-15.

6. EXHIBITIONS/FAIRS

During the month of December, 2014, the Corporation participated in following exhibitions/Fairs organised for the benefit of Persons with Disabilities:

- a) The Corporation sponsored 3 beneficiaries in East Himalayan Expo.- 2014 held from 7-15 December, 2014 at Kanchanjanga Stadium, Siliguri. The total sale made by beneficiaries during the event was Rs.1.64 Lakh.
- b) The Corporation participated in Public Information Campaign at Batala, Dist. Gurdaspur (Punjab) from 10 to 12 Dec., 2014.
- c) An Awareness Camp was oorganised by the Corporation on 15th and 16th December, 2014 at Katwa, Mongolkote (West Bengal). The Camp was attended by CMD, NHFDC and officials of the Corporation. At the said Camp, Aids and appliances were distributed amongst 200 Persons with Disabilities.
- d) NHFDC organized an Assessment-cum- Awareness Camp for PwDs with the help of Indian Red Cross Society, Faridabad at Sector-28, Faridabad on 25.12.2014 on the occasion of Good Governance Day.

- 3. Issue of selection letters to 25 persons belonging to OBC category for free vocational training sponsored by NBCFDC and to be conducted by M/s. HARDICON, Delhi.
- 4. Distribution of Scholarship Awards to two (02) students with disabilities under Scholarship scheme of Department of Disability Affairs, Ministry of SJ&E, Govt. of India and implemented by NHFDC.
- 5. ALIMCO distributed 15 (fifteen) Tricycles, 05 (five) Wheel Chairs, Ten (10) crutches, one (01) MR Kit and one (01) Brail Kit to the PwDs as assessed by Indian Red Cross Society, Faridabad.
- **III.** In addition to the above, the following activities were undertaken at the camp for the benefit of Persons with Disabilities/Backward Classes
 - a) 125 Persons with Disabilities were counseled by NHFDC officials to avail benefit under different schemes of the Corporation.
 - b) M/s. HARDICON registered 130 PwDs for Vocational Training under the schemes of NHFDC.
 - c) M/s. HARDICON registered 35 Persons belonging to Backward Classes for skill training under schemes of NBCFDC.
 - d) NSIC registered 41 PwDs for Vocational Training under the schemes of NHFDC.
 - e) Office of the District Social Welfare Officer, Faridabad received application forms from 06 PwDs for pension and 20 application forms for Scholarship to Students with Disabilities.
 - f) VRCH, Delhi registered 101 PwDs to assess them for job suitability and skill training.
 - g) Under the Jan Dhan Yojna, IDBI Bank Ltd. received application from 30 persons to open new accounts, whereas, State Bank of Patiala received application from 10 persons.
 - h) Indian Red Cross Society, Faridabad in association with ALIMCO assessed 107 PwDs for their requirement of Assistive Devices under the ADIP Scheme of Ministry of Social Justice & Empowerment, Govt. of India.

CMD, NHFDC alongwith officials of the Corporation attended the National Award for Persons with Disabilities (PwDs), 2014 at Vigyan Bhawan, New Delhi.

MoU was signed between the Corporation and Rural Electrification Corporation Limited (REC) for availing Rs.1.2 Crore from the latter to be used for providing skill training to 1000 PwDs.

c) 18th December, 2014

Meeting of Board of Directors of the Corporation was held at Corporate Office of the Corporation at New Delhi.

d) 22nd December, 2014

A meeting was held with GM, Andhra Bank on was held at Hyderabad for flow of collateral free loans to PwDs through branches of Andhra Bank with refinance from NHFDC. Manager (Project), NHFDC attended the meeting.

e) 23rd December, 2014

MoU was signed between the Corporation and Engineers India Limited (EIL) for availing Rs.0.36 Crore from the latter to be used for providing skill training to 300 PwDs.

f) 24th December, 2014

A meeting was held between CMD, NHFDC and Shri B. Pradhan, Principal Secretary, Backward Classes Welfare Department, Secretary, Social Welfare Department, Government of Bihar and representatives of Nationalized Banks (IDBI and Punjab National Bank) at Patna for implementation of NHFDC Schemes in the state.
